Chairman Willie Huff called the meeting to order at 1:30 PM and welcomed everyone. Chairman Huff then called for the review of the October 3, 2019 minutes. Chairman Huff called for a motion to accept the minutes. Commissioner Tom Lariviere made a motion to accept the minutes, seconded by Commissioner Jenny Williams, and the motion carried with none opposed.

Ms. Karana Carroll, Administrative Officer, then provided the MSWIN Status Update for October 2019. She reported information on MOUs, special event talk groups assigned, activities the WCC staff participated in during the month, the number of current MSWIN users, the number of pushto-talks, the top ten (10) state agencies/number of devices by system use, and the top ten (10) local/other agencies/number of devices by system use.

Ms. Carroll provided an update on WCC contract status. There were no changes.

Mr. Bill Buffington provided an update on the WCC projects. Two (2) projects are pending FEMA approval – Canton and John C. Stennis Space Center. WCC is anticipating completion of the Canton project by the end of the year. Four (4) vendors are looking to co-locate – AT&T, T-Mobile, FirstNet, and Verizon. Additionally, Mr. Buffington commented on the old radios (FDMA) being used by some entities and that the commission needs to encourage them to upgrade to the newer radios (TDMA).

Chairman Huff called for the report of the Procurement Committee. Chairman Perry Waggener reported that there was one (1) procurement request. This request was from the City of Ridgeland for \$543,675.00 to upgrade radios and includes 105 APX 4000 portable radios, 67 APX 4500 & 1500 mobile radios, and microwave system repair. Approval for this request is pending until receipt of official minutes from the Ridgeland Board of Alderman which met on Tuesday, November 5, 2019. Ridgeland Police Chief, John Neal, was present and had no comments. Commissioner Waggener made a motion to approve, seconded by Commissioner Wayne Vaughn, and the motion carried with none opposed.

Chairman Huff called for the report of the Governance/Interoperability Committee. Commissioner Lariviere stated there was nothing to report. The committee had not yet met.

Commissioner Lariviere motioned to refer the report, seconded by Commissioner Waggener, and the motion carried with none opposed and with Commissioner Steve Gray abstaining.

With no further business to report, Chairman Huff then announced the next monthly meeting will be at 1:30 PM, December 5, 2019, in Room 145 of the Woolfolk Building at 501 North West Street, Jackson, MS. Chairman Huff entertained a motion to adjourn. Commissioner Vaughn motioned to close and the motion carried with none opposed.
